Autodesk FY23 Q4 NAMER 0% Financing Offer Frequently Asked Questions

1. What is the Autodesk FY23 Q4 NAMER 0% Financing Offer?

Autodesk has arranged with select financing partners to have them provide 0% Financing for qualified enduser customers in the United States and Canada on eligible purchases of Autodesk subscriptions with 3-year terms.

Purchases can be made directly from Autodesk or through Authorized Resellers. (ACS product purchases must be made through an Authorized Reseller to be eligible). The 0% Financing offer begins on November 1, 2022, and will remain available through January 6, 2023.

The Financing offer is subject to customer credit approval and eligibility criteria as defined by the partnering financial institutions. All financing arrangements are between commercial end customers and the partner financing companies. Autodesk is not providing financing.

This offer requires customers to make annual payments to the partnering financial institutions. Alternative payment terms may be available but may carry an additional cost which will be the responsibility of the customer. Please consult one of the partnering financial institutions listed in question #8 for additional information on alternative payment terms.

For purposes of this document, all references to subscriptions "switched from maintenance" or "transitioned from maintenance" are references to what was previously known as "Maintenance to Subscription" or "M2S".

2. What subscription types and term lengths are eligible for the Autodesk FY23 Q4 NAMER 0% Financing offer?

Financing under this offer applies to

- Purchases of select 3-year term product subscriptions for excluded products listed on <u>Table 1</u> at the end of this document, may be eligible for 0% Financing with an approved exception from Autodesk sales leadership. See Question 3 below for details on how to submit exception requests.

- End user must meet the independent financing provider's credit approval criteria and requirements.
- All transactions must be completed by close of business January 6, 2023, to be eligible for promotional financing.
- Reseller Partners are required to provide 10-Digit Autodesk Order number (or ACS SOF Q-#### for select products) for each transaction prior to financing partner releasing funds and must provide that number to the financing partner.

- Financing partner must be provided the 10-digit Autodesk Order number (or ACS SOF Q#### for select products) by close of business January 6, 2023, for the transaction to qualify for 0% financing.
- Subscription Renewal purchases must be eligible for renewal on or before January 6, 2023, per Standard Autodesk Subscription Renewal policies.
- Pro-Rated Subscriptions are eligible provided the existing subscription has at least 24 months remaining in its term (select ACS products may not be pro-rated).
- Consulting Services, partner training and services and/or other related purchases are not eligible for this offer.
- The 0% Financing offer cannot be combined with any other offers, promotions or any discounts provided by Autodesk.
- Named accounts are not eligible nor are any of our customers on Enterprise Business Agreements, or the Token Flex, Flex or PPU offerings. Additionally, contracted accounts according to any relevant agreements such as VPAs (Volume Purchase Agreements) or ETRs (Extra Territory Rights) are not eligible.
- Government Account Customers are not eligible for this offer

3. What is the exception process for the Autodesk FY23 Q4 NAMER 0% Financing offer?

In order to be considered for exception, Autodesk Territory Sales Reps (TSR), Strategic Territory Sales Reps (STSR), Territory Account Sales Executives (TASE), Customer Success Specialists (CSS), Subscription Sales Executives (SSE), Autodesk Construction Account Executives (AE), or Autodesk Authorized Resellers must submit an exception request via the <u>0% Financing Request Form</u>. All required fields on the form must be completed in order to be considered for exception approval. Merely submitting the exception request does not entitle the customer to an exception. Exceptions may be granted only at Autodesk's sole discretion. An email response from <u>namer.financing@autodesk.com</u> will be sent to the submitter of the form within 2-4 business days informing them of approval or rejection of the request. Additional questions may be sent to <u>namer.financing@autodesk.com</u> – however the <u>0% Financing Request Form</u> must be completed to be considered for approval. <u>The final day for exception request submission will be Wednesday December</u> <u>28, 2022.</u>

4. Are all Autodesk products eligible for 0% Financing?

No. Products must be listed on the Autodesk Authorized Reseller Pricelist published as of November 1, 2022, and must NOT be listed in the exclusions list in **Table 1** at the end of this document. The product exclusions list is subject to change at Autodesk's discretion. Only new and renewing product subscriptions with 3-year term lengths are eligible. Excluded products listed on **Table 1** at the end of this document may become eligible with an approved exception from Autodesk Sales Leadership. See Exception process details in question #3 of this document. Approved exceptions may be granted at Autodesk's sole discretion.

5. What is eligible for exception under the Autodesk FY23 Q4 NAMER 0% Financing offer? Excluded products listed on <u>Table 1</u> at the end of this document may become eligible with an approved exception from Autodesk Sales Leadership. See Exception process details in question #3 of this document.

If the projected amount to be financed exceeds \$400,000 USD or CAD, an exception approval must be obtained.

If an opportunity includes discounts such as CCA (Autodesk Deal Discount Approval), an exception approval must be obtained.

Autodesk reserves the right to consider exception requests on a case-by-case basis. Any decisions regarding exception requests are at Autodesk's sole discretion.

6. Are Maintenance renewals eligible for 0% Financing?

No, only contracts for new and renewing single-user 3-year subscriptions are eligible for 0% Financing. Subscription renewal purchases (for eligible products or those approved by exception) must be eligible for renewal on or before January 6, 2023, per standard Autodesk subscription renewal policies.

7. What is the program end date?

The offer will remain available through January 6, 2023. Autodesk may change the conditions of this offer at any time. In the event of a change, Partners will be notified by Channel News or Channel Flash at least 5 business days prior or by posting the revised terms on One Team Source.
